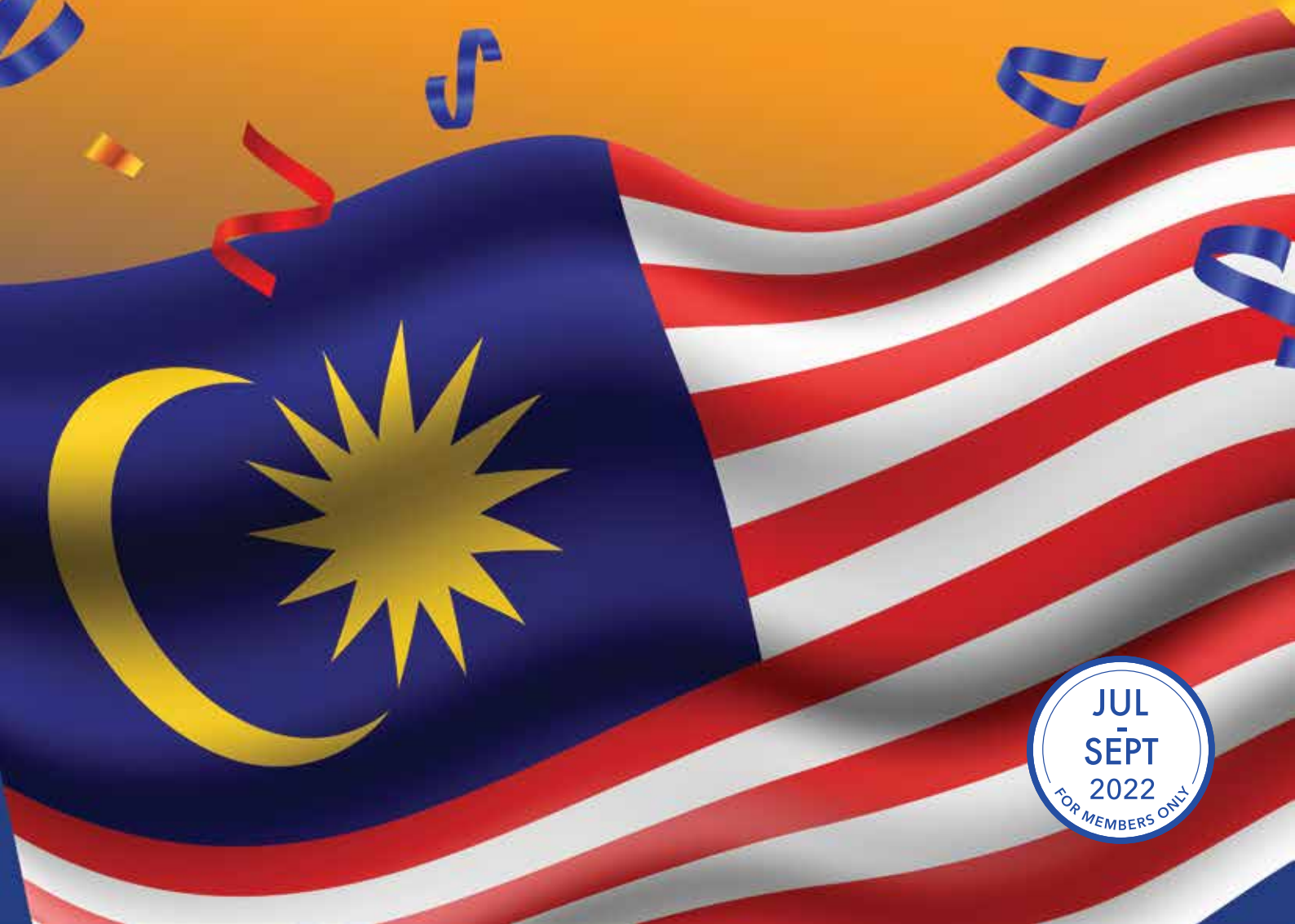

# PENANG SWIMMING CLUB EGM 26TH OF JUNE 2022



After the lengthy delays in calling, holding and completing the Club 2021 AGM, partly due to Covid restrictions, our Club was left with only 53 days from the 8th of May AGM until current valid Club budgets expired on the 30th of June 2022. The 56-day delay between the failed 13th of March AGM and the "fresh" 8th of May AGM had tightened the timeline considerably.

Upon taking office, the new MC quickly realised that financial matters were very much in arrears. No Club budgets 2022-23 had been commenced and S&G budgets, although submitted to the Club by the imposed S&G "deadline", of 17th of February, had not been touched.

Hence the concentration had to be on Club budgets, so that the Club could continue to operate normally post the 30th of June. The last Sunday in June being the 26th meant the EGM Notices had to be sent out to members by Friday the 10th, or Saturday the 11th of June, at latest.

The MC met this required deadline with a day to spare.

Before commencing the Meeting, the Chairman (Club President Mr. Chan Kean Hin), outlined some "housekeeping rules" regarding the expected respectful behaviour of members.

The Chairman then called the Meeting to order and commenced the EGM Agenda.

Item 1. - Rules amendments - After some discussion on the merits (or otherwise) of the proposed amendments relating to Club budgets, the Chairman announced that at the present time, there was insufficient quorum in the hall to amend the Rules, and therefore the Committee would not consider any Rules amendments at this time.

The Chairman then moved forward to: -

Item 2. - Proposed Club budgets to 31st of March 2023 (Including CapEx and S&G) - After some lengthy discussion on these, in particular the Baby Pool project, Mr. Kenny Koay Lee was requested to explain and outline the reported required renovation work required at the Baby Pool and surrounding area. This he did, at length and in great detail. Again, further discussion ensued,



the eventual outcome being that members became acceptant of the fact that major repair works were required to the Baby Pool, Female changing rooms, pump room, Snake Temple, old Scuba shed and minor incidental work to the main Swimming Pool.

After this major issue had been resolved to the satisfaction of members, the subsequent vote on the proposed budgets as presented at the EGM, was a unanimous, and therefore historic, approved vote. The EGM was therefore effectively concluded, and the Chairman thanked members for their' attendance and declared the Meeting closed at 12.20pm.

The attendees then retired to the Captain's Restaurant for a "sit down" lunch.





# PENANG SWIMMING CLUB 2021 AGM 8TH OF MAY 2022

The failure of the Club Committee election process, at the initial 2021 AGM on the 13th of March 2022, resulted in the, then, President/Chairman (Mr. Najieb Ariff), declaring said Meeting “null and void”. Thereafter, what was termed a “fresh” AGM, was scheduled for 3.00pm on the 8th of May 2022.

8th May 2022 – The Meeting was brought to order by the incumbent President, Mr. Najieb Ariff, at precisely 3.00pm, after confirming that there were 431 members in attendance.

*For those members in attendance on the 8th of May at the AGM, and who remained until the Meeting was officially closed at 8.17pm, the events of that day may still be reasonably fresh in their memory.*

*To try and give a summarised version of said events, questions posed, responses received, comments, criticisms, statements and counter statements etc., at the 8th of May AGM, would require a Nautilus article almost as long as the 27 pages of the draft\* Minutes of said Meeting. Even to mention, or include herein, what some may loosely refer to as “highlights” from the AGM, could lead to accusations of “biased reporting” by those Club members and staff, collectively referred to as the “Editorial Board” (EB), tasked with compiling this issue of Nautilus.*

*The 2022 Club AGM is currently scheduled for late September, and, at least 14 days prior to that AGM, will be the circularisation to members of the Club Annual Report 2021-22. The Annual Report 2021-22 will, as always, contain the Minutes of the previous AGM.*

*The EB therefore, urges those members, who wish to know the full details of the “dialogue” at the 2021 AGM, to read the transcription of the recorded Minutes of the 2021 AGM, contained within the forthcoming 2021-22 Club Annual Report, and to form their own conclusions therefrom.*

*\*The term “draft” above is used to indicate that the Minutes have not yet been reviewed to correct any typing errors and/or punctuation etc. It does not infer any “re-writing” of the content, which is a transcription of the recorded dialogue that took place between members from the Floor and members of The Committee.*

## AGENDA

**Item 1 - ELECTION OF CLUB COMMITTEE EXCO AND SEVEN OTHER CLUB COMMITTEE MEMBERS.**

Voting closed at approximately 5.00pm, and ballot boxes were removed to the Captains Restaurant Formal Dining Room, accompanied by 6 scrutineers and Club staff, for the vote counting process.

**Item 2 - TO CONFIRM THE MINUTES OF THE ANNUAL GENERAL MEETING HELD ON THE 20th SEPTEMBER 2020.**

The approval of the Minutes of said Meeting was proposed, seconded and approved.

**Item 3 - TO CONSIDER AND, IF APPROVED, ADOPT THE ANNUAL REPORT AND ACCOUNTS FOR THE YEAR ENDED 31st MARCH 2021.**

The approval of the Annual Report and Accounts for the Year Ended 31st March 2021, was proposed, seconded and hence approved and adopted.

**Item 4 - TO CONSIDER AND, IF APPROVED, ADOPT THE PROPOSED BUDGET.**

The approval of the budget was proposed, seconded and hence approved and adopted.

**Item 5 - TO ELECT SIX (6) MEMBERS OF THE ELECTION COMMITTEE**

The following six nominees were duly elected, there being no other nominations: -

**Item 6 - TO ELECT THE CHAIRMAN OF THE DEVELOPMENT COMMITTEE FOR A TERM OF THREE (3) YEARS.**

Mr. Scott Ong Chen Min was duly elected as Chairman of the Development Committee for a period of three years.

**Item 7 - TO ELECT AN INTERNAL AUDITOR AND TO FIX HIS/HER REMUNERATION OR HONORARIUM.**

Since there were no nominations, the Chairman announced that there would be no Internal Auditor for the upcoming term.

**Item 8 - TO ELECT EXTERNAL AUDITORS AND FIX THEIR REMUNERATION.**

In a unanimous vote, Stephen & Co were re-elected to office as Club auditors.

**Item 9 - TO CONSIDER AND DECIDE ON THE PROPOSALS SUBMITTED BY MEMBERS PURSUANT TO CLUB RULE 34(h).**

- The new IT software budget was cancelled.
- The proposal(s) regarding various Rules amendments was withdrawn on the 8th of March 2022.
- The proposal regarding the Staff Gratuity Fund was withdrawn.
- To restore and the adaptive re-use of the Renong House. The Chairman stated that because neither the proposer or seconder of this proposal were in the House, the proposal would not be carried out.

**Item 10 - TO CONSIDER ANY OTHER MATTERS AS APPROVED BY THE CHAIRMAN**

There followed a brief questioning of the Chairman regarding the failed 13th of March AGM, such questioning relating to unnumbered ballot papers (“fake” or otherwise), knowledge or otherwise of the source of these unnumbered ballot papers, declaration by the Chairman of a “null & void” AGM, the filed police report and police investigation.

The Chairman responded finally by stating that the Committee had closed the agenda as there was a proposer and seconder.

The Chairman then announced the results of Agenda Item No.1 (to elect officials and members of the Committee for the ensuing year up to June 2022 or as near thereto as convenient).

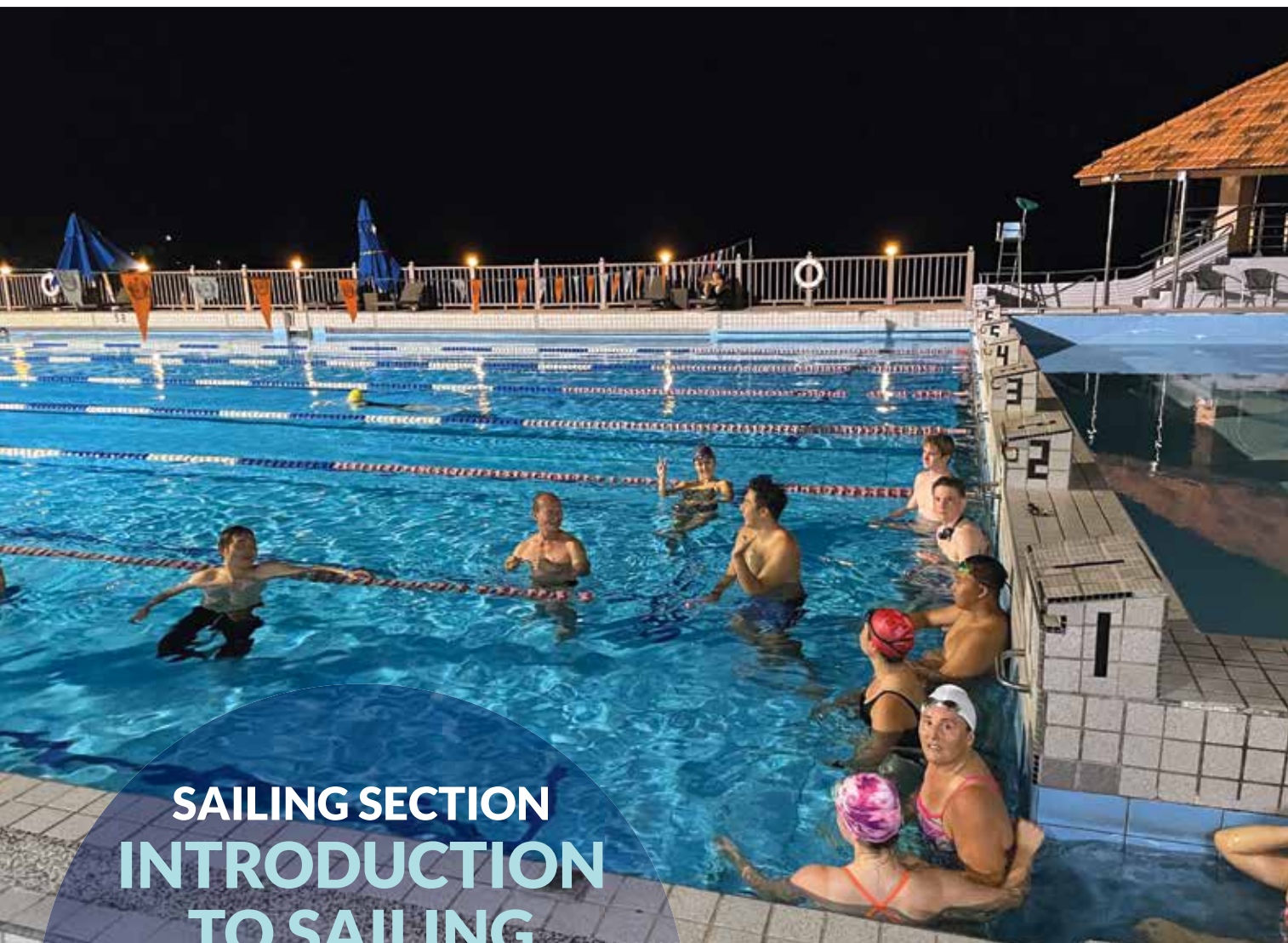

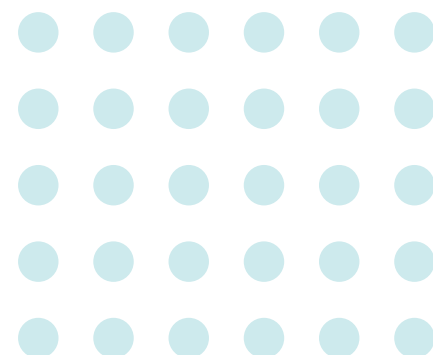
With these basic skills, sailors can continue to practice their single-handed sailing, explore double-handed boats, and even begin windsurfing.

## SCUBA SECTION

The AGM season. Five over, one more to go. In total, six. Two from the Scuba Section, four from the Club, one being null and void and another an EGM. So here we are. Moving forward as ever.

If Scuba news had not gone beyond its walls, we are delighted to highlight a few here. To save money for the Section, documents and call for AGM have gone digital. In the 2nd July AGM for 2022/23, we welcome 2 new committee members and celebrated our belated 55th anniversary, the Emerald Jubilee (1966-2021). Led by our Club President, K.H. Chan, his Team, BSAC Instructors and Section Committee, we marked this milestone by cutting a 'Scuba' cake.

The Chairman, C.L. Teh, in his speech noted an unprecedented increase of 20% in membership to 235 within the first half of the year. Ongoing Trial dives for all will spur more to join us and take up the sport. The eight new BSAC Open Water Instructors (OWI) are a timely addition to our Team. At the same time, all qualified Instructors are welcomed to drop by and contribute to the next generation of divers. The Club President, K.H. Chan, pledged his 101% support for the Section and in his banter quipped that CL should be Scuba Chairman forever.

BSAC OWIs are the pillars of the Scuba Section. Without them, the Club has to engage Instructors and pay them or forced to stop conducting diving classes. The last batch of OWIs here were qualified in 2006. They are K.C. Lee (OWI #5111), M.W. Chin (OWI #5112), Eddie Foo (OWI #5255), C.C. Ong (OWI #5256) and S.N. Teow (OWI #5257) who were examined by National Instructor, the late Dr. Y.C. Lee from Singapore. Sixteen years later, and after 4000+ BSAC OWIs qualified worldwide, we make a comeback. Better late than never.

It is a miracle that the Section pulled through. Thank God for healthy senior Instructors who are still active volunteers and stand in the gap. Here are a few words from two of those involved in the Instructor Training Course (comprising the Instructor Development Course & Instructor Foundation Course) held in Kuantan, 28th May - 3rd June. Danny Lim (AI #0279) : "The next level after being an OWI is becoming an Advanced Open Water Instructor (AI). An OWI

can conduct and examine the Ocean Diver, Sports Diver and Dive Leader Courses. However, an Advanced Instructor (AI), conducts and examines the Advanced Diver Course and can set up a new BSAC Branch. My advice to the newly qualified OWIs is to commit and train new divers, learn new skills, maintain standards in training and in Open Water Assessments. Also to work as a Team. This batch of Instructors under my charge have a good attitude and commitment towards the Section. They are willing to learn. Form now on, will involve them in organising and training both the theory and pool lessons leading to the Open Water Assessment."

Ladies first. Sulin (OWI #9302): "There were talk of an Instructor course way back before the MCO. Unperturbed by the MCO, we prepared ourselves with weekly online DL classes. The closest BSAC National Instructor (NI) to qualify OWIs is Les Skelton based in Bangkok. But International borders were closed till April this year. In May, BSAC 0903 in Kuantan arranged to bring the NI over. Serious preparation then began. Both our Sirs, Danny and Eddie were of great help and without their unreserved impartation of their knowledge, experience and guidance, we would not have become OWIs today and achieved a 100% pass. The most difficult task in the Instructor Course was that the presentation topic was only given the night before we were examined. This is on top of having to cope with the overall hectic 6-day schedule with last minute changes and lack of sleep. Encouragement and help from friends go a long way. My advice to OWI-to-be is to prepare yourself physically and mentally, free to share knowledge with and learn from one another, continuously improve from constructive feedback and give yourself a pat in the back for a job well done. Bravo!

The next dive expedition will be announced when the details are worked out. We thank CC Ong (OWI #5256) for coming forward to help SN Teow (OWI #5257) in the last Open Water Assessment in Pulau Tenggol. After a lapse of more than 25 years, the Advanced Diver Course is back. The response for the recent Ocean Diver and Sports Diver Courses is overwhelming. Please be patient as we work out a schedule for more students while ensuring safety which is always topmost in our minds.
